- For the academic year 2011/12 EMLE received 623 applications.

## European Doctorate in Law & Economics (EDLE)

- DAAD research grant: The tri-national doctorate programme EDLE receives the DAAD sponsorship for "International Doctoral Studies in Germany" (IPID). EDLE was chosen from more than 80 applications as the only programme offered by a law faculty. The DAAD's sponsorship once more strengthens the University of Hamburg as a centre for international and interdisciplinary doctorate studies. Already in 2010 EDLE was elected as an Erasmus Mundus Excellence Programme by the European Commission.

- 230 Applications received: For the academic year 2011/12 EDLE again received approx. 230 applications for the 15 stipends. The stipends are sponsored by the European Commission under Erasmus Mundus and by the Partner Universities. The selected candidates will receive notice soon.

- Seminar, University of Maastricht, 3-4 March: Second year doctoral students presented their research at a joint seminar of the Universities Maastricht, Paris Ouest Nanterre La Défense, Paris II and Rotterdam.

- European Studies in Law & Economics: The first four volumes have been published in this peer-reviewed book series at Intersentia. The series presents an interdisciplinary perspective on the effects of laws on people's behaviour and on the economic system [\[more\]](#).
